The Superintendent reported:

- Changes in law necessitated changes in the interdistrict transfer policy.
- Staffing needs: additional substitutes, a speech teacher and a maintenance substitute
- Returning staff: school psychologist, Mr. Wallis for Science, Ms. Becky for special education and Vista Hill.
- CAASPP testing is complete.
- The Student Study Team update was successful and Special Education testing will be completed within 30 days of the start of school.
- The LCAP is complete, including the federal addendum.
- The staff calendar for 19-20 was determined, including back to school night.
- She is exploring making a video for Tesla to provide solar panels to schools.

- Current enrollment is 43 students 23 in Old School House and 20 in Ritchie Hall.
- YTD Attendance, through April, was 95.02%
- 2019-20 Projections: twelve TK/K; eleven 1st and 2nd graders; twelve 3rd and 4th graders; and twelve 5th through 8th graders.

- The 1st and 2nd grade teacher is looking at admin programs.
- Mandated Reporter training must be completed yearly.

- Putting it All Together (PIAT) LCAP training was attended at SDCOE.
- Orff Schulwerk was discussed with the music teacher.
- Professional Development opportunities were discussed with each teacher including:
 - Best Behavior: Building Positive Behavior Interventions & Supports
 - o Restorative Practices
 - o CPI
 - Suicide Prevention
 - New Social Studies curriculum training for grades K-5
 - Mathematics training for grades 7-8.
