A. Adopt Resolution 20-002 of the Final Negative Declaration for the Annex Project PROPOSAL: To adopt a resolution accepting the responses to the comments received during public comment period, approving the Negative Declaration, and authorizing staff to process a Notice of Determination with the County of San Diego.

BACKGROUND: The Annex to Spencer Valley School and Site Improvement project proposes the construction of an Annex to the school. It includes the addition of a 7,832 square foot school building, improvements to the existing driveways, a new parking lot, modifications to the striping on the existing parking lot, and the provision of water, septic, power and low voltage electrical and data lines to service the new annex.

The school district conducted an Environmental Initial Study, which determined the proposed project will not have a significant impact on the environment and the preparation of an Environmental Impact Report will not be required. This document represents the project's Negative Declaration.

The Draft report was published on June 19, 2019 for public comments.

Public comments addressing the findings of the Draft Negative Declaration and/or completeness or accuracy of the Initial Study and checklist were received during the public review period, which ended at 3 PM on July 17, 2019. The responses to these comments are provided.

B. Approve Student Transfer Request for 19-20

PROPOSAL: To approve student transfer requests for the 19-20 school year.

BACKGROUND: One student from Spencer Valley to Ramona Unified. The student has been attending Julian Elementary for 18-19. Three students from Julian Elementary into Spencer Valley.

C. Approve Services Agreement between San Diego County Superintendent of Schools and SVESD for Teacher Induction Support

PROPOSAL: To approve a Services Agreement for Teacher Induction Support for 2019-2022.

BACKGROUND: Teachers with Preliminary or Level 1 credentials must complete a CTC-approved teacher induction program or obtain a National Board of Professional Teaching Standards certification to clear their credential. Under the agreement, SDCOE will provide Teacher Induction support to District Preliminary and Level 1 credential holders. The partnership provides a CTC-approved program to allow such credential holders to meet the renewal requirements for a Clear or Level 2 credential.

BUDGET IMPLICATIONS: \$2500 per participating teacher, from the General Fund. SVS has two (2) teachers requiring Teacher Induction.

D. Approve Memorandum of Agreement with San Joaquin County Office of Education for Programming and Maintenance of SEIS/SIS Integration Components and Services PROPOSAL: To approve the MOA with the San Joaquin County Office of Education.

BACKGROUND: The San Joaquin County Office of Education (SJCOE) Center for Educational Development and Research (CEDR) has developed and maintains the Special Education Information System (SEIS) that is used for online management of IEPs and Special Education records. The Student Information System (SIS) is used to track student data such as daily attendance. The CEDR is working on setup/configuration and support of integration components and services to allow data transfer between SEIS and SIS.

BUDGET IMPLICATIONS: \$0.75 per student based on the current district special education student count as of December 1 CASEMIS report. Current maintenance fee is \$230.25 based on CASEMIS count of 307 students.
