The project is an annex to the existing school. It includes the extension of the existing school parking lot and driveway, enhancing the existing driveway, the construction of a 7,832 square foot school building, and a new parking lot for the new building. The school building will include 2 preschool classrooms, a flex- use classroom, a kitchen, offices and storage. The total project building envelope is approximately ½ acre in size. All work will be on the western end of the site and front Highway 78. Approximately 3 ½ acres of the property will be untouched and remain in its current condition. The placement of the new building and circulation improvements will be done in such a manner as to allow the existing trees to remain on site and enhance the landscape.
9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The Spencer Valley Elementary School is immediately to the North of the proposed annex. A motel is on the property directly south of the proposed annex. There is a parking lot directly across the street (to the west), and there are existing commercial uses to the north and south sides of the parking lot across the street.

The Division of State Architect will approve the project; the County of San Diego Health and Human Services approval will be required for the kitchen, and approval from the Engineering Services Division will be required for the enhancement of the existing driveway on highway 78.

The project is located next door to the Spencer Valley Elementary School. Its address is 4396 Highway 78, Santa Ysabel, CA 92070. Here is a map showing the regional location of the project.

Figure 3 - Aerial Photograph

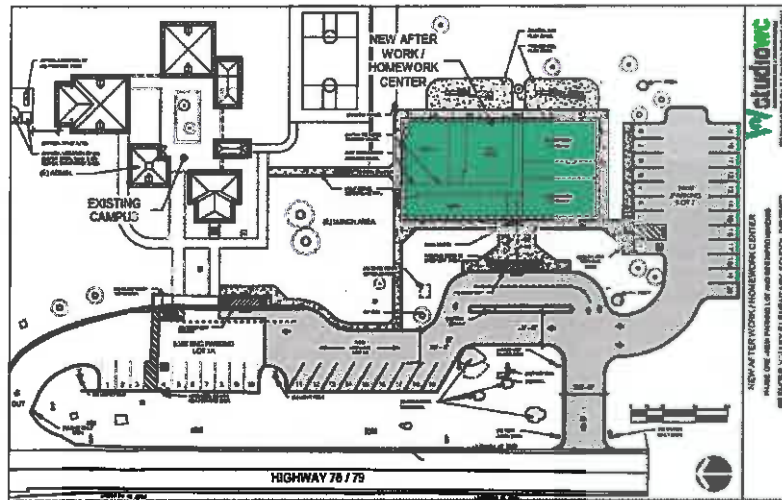


Project Description:

The project is an annex to the existing school. It includes the extension of the existing school parking lot and driveway, the enhancement of the existing residential driveway to be used as a vehicular entry point from Highway 78, the construction of a 7,832 square foot school building, and a new parking lot for the new building.

The school building will include 2 preschool classrooms, a flex- use classroom, a kitchen, offices and storage. The total project building envelope is approximately ½ acre in size. All work will be on the southern end of the site and front Highway 78.

Approximately 3 ½ acres of the property will be untouched and remain in its current condition. The placement of the new building and circulation improvements will be done in such a manner as to allow the existing trees to remain on site and enhance the landscape. The following diagram shows the initial concept drawing for the annex and its relationship to the existing school and environmental setting.

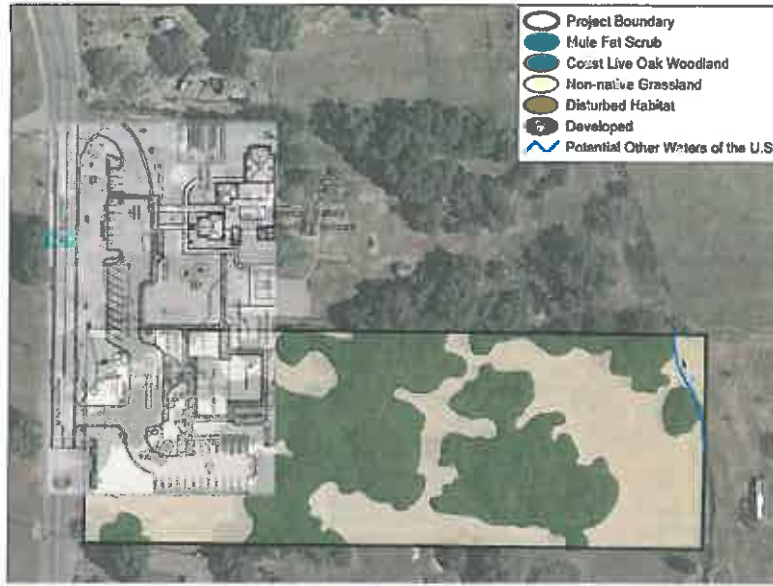


Environmental Setting:

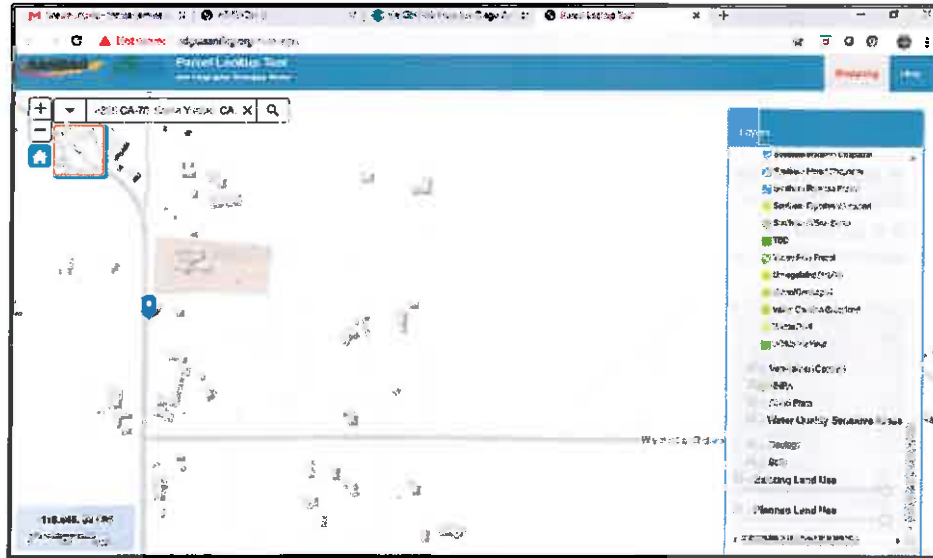
A 2015 environmental analysis was conducted for the purchase of the two parcels of property that now comprise the site for the proposed annex. The analysis showed that there are oak trees on the property which may be considered environmentally sensitive. As much as possible, the new building will be situated on the property to avoid the removal of any of the oak trees or existing boulders. In fact, the District is proposing to construct a classroom building that is rectangular in shape so that it will better fit to the site, and will better serve the community. The following diagram shows improvements superimposed on the environmental analysis. As can be seen in the diagram on the next page very little of the property is impacted by the development. A field investigation conducted on Friday May 3, 2019 verified that there are five (5) oak trees and a cluster of boulders that are near the building area. The outline of the 63 ft. by 123 ft. building and the parking area was done, and it confirmed that the trees and rocks could be avoided. If by chance, there are oak trees to be removed, the District will replace them on a one to one basis.

Over 3 acres of remaining land is untouched by the project. Additionally, the project is outside the 100 year flood plain, and outside the blue-line influence area (designate waterway).

The following shows the project superimposed on the existing biology.



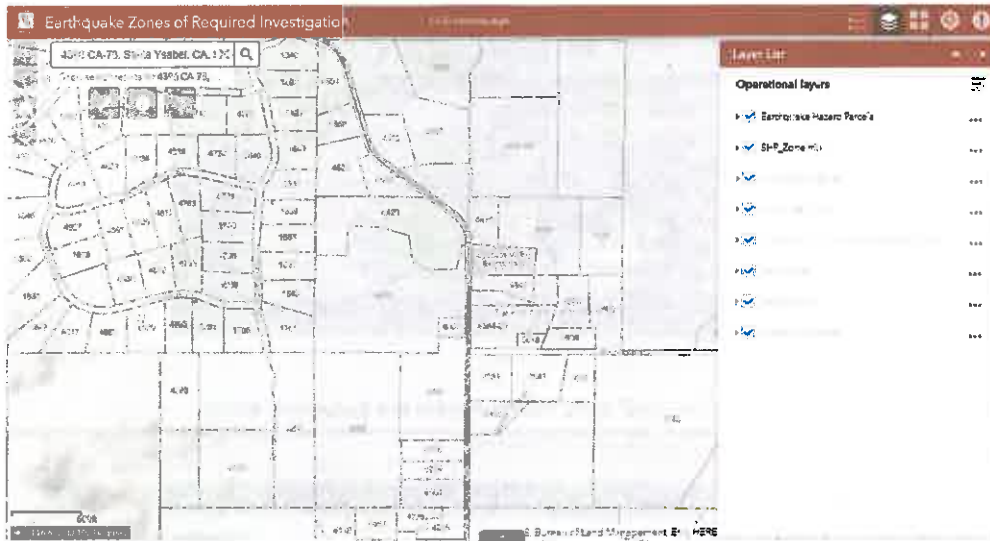
The following diagram shows the land uses that surround the proposed annex:



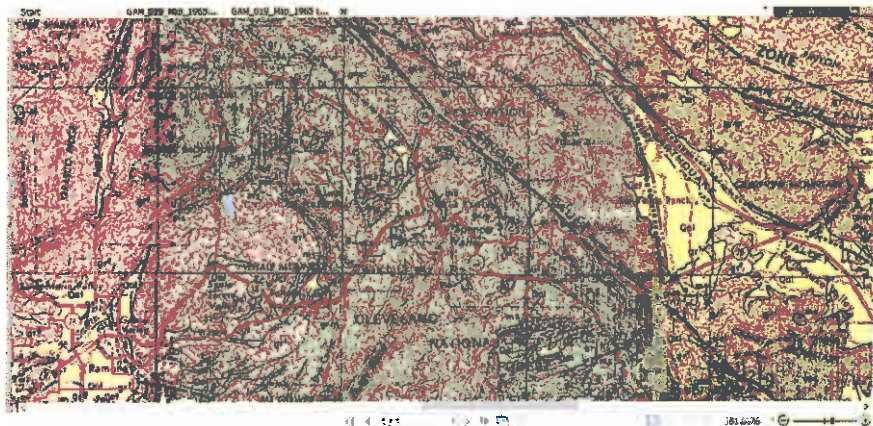
The proposed use is compatible with the surrounding land uses.

Fault Line:

According to San Diego SANDAG and SANGIS maps, the site is not located within an Alquist-Priolo Hazardous Zone. The nearest fault is the Lake Elsinore Fault. It is 3 miles north east of the town of Julian and on the other side of the mountain.. The following diagram illustrates that the project site is not within a fault zone.

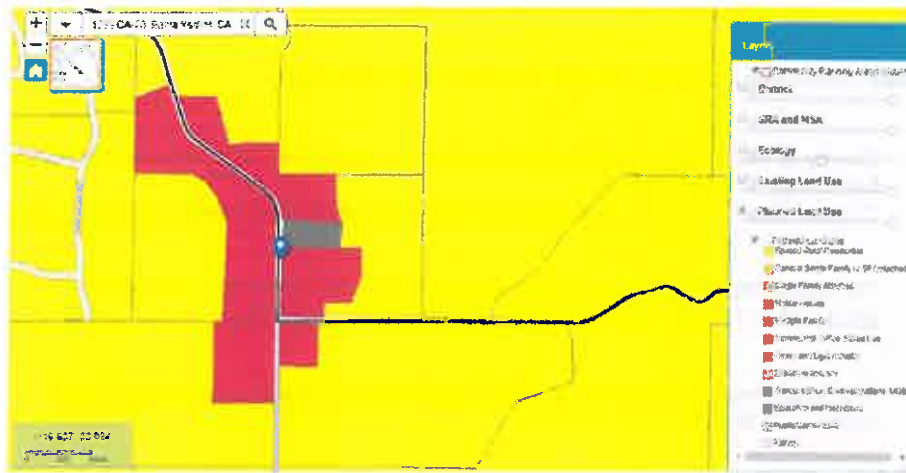


Here is a segment of the map which shows the active faults near the Julian/Santa Ysabel communities. The new classroom building will be designed and constructed in accordance with Title's 22 and 24. That means that it will be structurally able to withstand moderate earthquake activity. Furthermore, the site is not located on an active fault.



Land Use:

The project is located within the Julian Community Plan, and the General Plan designation is "Rural"; the zoning is C36 (Commercial, Office, and Mixed Use). Section 2362 of the San Diego Zoning Code states that Small Schools are an allowable use in the C36 zone. Therefore, the proposed project is compatible with the local general plan and zoning.



Here is a snapshot of the C36 zoning code language:

C36 GENERAL COMMERCIAL USE REGULATIONS

2359 INTENT.
The provisions of Section 2360 through Section 2369, inclusive, shall be known as the C36 General Commercial Use Regulations. The C36 Use Regulations are intended to create and enhance commercial areas where a wide range of retail goods and services are permitted. Typically, the C36 Use Regulations would be applied where central area commercial facilities were desired in association with administrative and office uses. Various applications of the C36 Use Regulations with appropriate development designations can create community or regional shopping complexes, central business districts, or small but highly diverse commercial developments.

2362 PERMITTED USES.
The following use types are permitted by the C36 Use Regulations:

Conclusion and Recommendation.

It is the conclusion of the Spencer Valley School Board that the project is a minor addition to the Spencer Valley Elementary School, and that it will have no significant impact, immediate or cumulative, on the community, the environment, or the cultural aesthetic of the Julian and Santa Ysabel communities. The Superintendent/Principal is recommending that a Negative Declaration of Environmental Impact be prepared, approved and filed for the project.
